

# "Defund the Police" is a Failed Experiment. Time for a Re-fund!

he national defund the police movement began shortly after the death of George Floyd in May of 2020 with calls for gutting police and sheriff departments or in some cases demanding the outright abolition of police. Here in Los Angeles County, the defund movement was supported by the Board of Supervisors when they placed the unconstitutional Measure J on the November 2020 ballot, which was passed by the voters and knocked down by the Coalition of County Unions and ALADS in court. During that time span, the great experiment of alternatives to incarceration called for the elimination of bail and reduction of police, leading to the largest rise in crime in decades. Commercial robberies, burglaries, home

invasion robberies, and homicide are up substantially. The citizens of Los Angeles County do not feel safe.

The shortage of deputies and officers countywide coupled with the progressive policies of District Attorney Gascón have also fostered an unsafe environment for Angelenos and have emboldened criminals. The situation is so out of control that even the staunchest left progressives are calling for additional funding

to hire more police officers. "We have to be less tolerant of all the bullsh\*t that has destroyed our city," said San Francisco Mayor London Breed at a news conference addressing the rise in crime.

"People are still against crime and people want to be safe," said former Philadelphia Mayor Michael Nutter in an interview. "You're seeing in communities all across the country that when folks actually came to grips with the conflict of rising crime rates and an effort to quote unquote take away from policing, the public, being way ahead of the politicians as usual, figured out 'no no no, that's not a good idea, we want to be safe."

Even President Biden, during the State of The Union speech, addressed the need for more police. "We should all agree: The answer is not to defund the police. It's to fund the police. Fund them. Fund them with resources and training."

Now the progressives and the Democrats are trying to flood the airwaves with pro-law enforcement soundbites to appease their constituents because the anti-police rhetoric is no longer trendy, so they are jumping off the bandwagon. I want you to remember this time and moment because we will see it again; these politicians waver back and forth depending on where the wind blows. Where did we stand? On the side of the law, public safety and keeping our neighborhoods safe; this is where you will always find the deputies and all of law enforcement. While elected officials ponder their position, ALADS is planning for the future and working with stakeholders to figure out real solutions to public safety.

After this miserably failed experiment, the public has decided that there need to be more police and stricter laws to keep our communities safe.

ately, there's been a lot of talk amongst our elected officials about the need to increase the minimum qualifications to become a cop. Should an associate's degree be required? A bachelor's? Should we get tougher with the background checks? Maybe the tests need to be more difficult. Too often, politicians pass immediate judgment if there is an altercation between a cop and a bad guy. They are very quick to say it's not the bad guy's fault; it's because the cop didn't have enough higher education. It's insulting.

Let's talk about the minimum requirements to be a California State Senator. If you are a U.S. Citizen and registered to vote in the area, you are pretty much good to go. You don't even need a GED. Background check? You can have a felony conviction if it didn't involve things like bribes or theft of public funds (it's fine if you stole a car, as long as the car didn't belong to the government). Testing? None. If you can spell your name so they can put it on the ballot, you're in. It's no wonder these folks get things wrong so often.

This year, some of our state legislators, the cophaters, are at it again, and they are once again running in the wrong direction. There's SB

1000, which would require agencies to give the public access to encrypted police radio frequencies with limited exceptions for things like tactical and undercover operations. Our good friend, Senator Steven Bradford, has introduced SB 1088, which would effectively render the Peace Officer's Bill of Rights meaningless. Senator Bradford didn't stop there. He's also bringing us SB 1389, which would outlaw traffic stops for low-level

infractions. Then there's AB 2557, which would allow for increased public access to our personnel files.

President Ronald Reagan once said, "It isn't so much that liberals are ignorant. It's just that they know so many things that aren't so." Too many of our elected officials seem wrongly convinced that law enforcement agencies are chock full of "gangs," members of extremist hate groups and racists. God only knows what they think we are secretly talking about on our encrypted radio frequencies.

It's time for our legislators to take a break from attacking those who protect and serve their constituents. The homelessness issue here in California has become so bad it's drawn the attention of the entire world. Our schools are in a state of decline. Overall, our public transportation system is awful and the quality of our roads ranks 48th out of the 50 states. It's not as if there's a shortage of real problems here for them to tackle.

The good news is the pendulum does appear to be swinging back the other way. Polls are beginning to show a return toward sanity. George Gascón's approval rating is plummeting and the word "defund" has become extremely unpopular. # ALADS WINS!!!

#### ERCOM Affirms ALADS' Right to Negotiate Over Subpoena Power!!!

The County's Employment Relations Commissions (ERCOM) ruled in ALADS' favor in an "unfair employee relations practice" case where ALADS challenged the County's decision to grant subpoena power to the Office of Inspector General (OIG). ALADS argued that the County was obligated to negotiate with ALADS before either enacting the OIG ordinance or submitting a ballot measure to the voters concerning the OIG. ALADS also contended that the County violated its own labor ordinance when it failed to answer a series of information requests from ALADS about the scope of authority it was giving the OIG.

The County filed a motion to dismiss ALADS' complaint; however, ERCOM ruled that ALADS was entitled to a hearing on whether the County was required to negotiate the "effects" or "impacts" of its decisions regarding the OIG.

### ALADS Begins Wage Negotiations with the County

On November 22, ALADS Negotiations Team held its first wage negotiation session with the County. ALADS President James Wheeler and Executive Director Derek Hsieh led the introduction of the team while chief spokesperson and long-time police union lawyer Will Aitchison provided opening remarks, emphasizing the fact that you all have met the extraordinary challenges of these past couple years with incredible professionalism and continue to provide the best service to your communities.


This is one of the most challenging times for the middle-class, inflation is the highest in 30 years, and the cost of housing in and around Los Angeles County continues to increase. Meanwhile, your employer has not given you a pay raise since 2020. What the County decides to do during these negotiations will send a clear message about how they feel about the working class.

### District Attorney Gascón Should Stop Pandering and Start Following the Law

District Attorney George Gascón sent a demand to all police agencies in the Los Angeles County for lists of officers with Brady discipline after being slapped down by the Los Angeles Superior Court earlier in February. ALADS recommended that Gascón slow down, consult with experts in his office and avoid impulsive, politically motivated moves. In regards to Gascón's ill-advised demands, ALADS considered all options to enforce the law and to keep members informed of ALADS' efforts.

#### Homicides in Los Angeles More Than Double

Fox News reports that Los Angeles has experienced more than double the number of homicides during the first 12 days of 2021 than during the same period of 2020.



#### LA Times Reports California Homicides Jumped 31% in California

The *LA Times* reported that California homicides reached the highest total in 13 years, making 2020 the deadliest year since 2007. The 2,202 homicides in 202<mark>0 were 523 more</mark> than in 2019.

### Metro Board Approves \$75 Million Contract with LASD, LAPD and LBPD

### ALADS Works Behind the Scenes to Save Deputies' Jobs

On December 2, the Metro Board of Directors voted to approve funding the current law enforcement contract through June 2022, which is the end of the fiscal year. In addition, the Board directed staff to execute a contract extension for two six-month periods through June 2023.

The Metro Board also made moves to implement a pilot project to deploy transit ambassadors. In preparation for the meeting, the ALADS team put tremendous effort in working with stakeholders

and partners to provide information about your role in providing public safety on buses and trains.

The outcome and the show of support was promising and reflected the recognition of the contributions you make daily in your profession. However, it is an 18-month extension that allows the Board time to draft a Request for Proposal (RFP) for a new Law Enforcement Contract.





#### **Legal Defense Fund**

Legal Services represent legal fees and costs to cover member related law enforcement exposures, promotions, payroll matters, UFC's and other general labor issues. It also covers all administrative, civil, and criminal proceedings against ALADS members as well as ALADS corporate legal matters.

#### Payroll and Related Costs

Overall salaries and benefits paid to ALADS employees that conduct day-to-day operations in the office. There are currently 23 employees.

#### Operating Services and Supplies

Expenses related to regular operation of the association including but not limited to office equipment and supplies, building repairs and maintenance, utilities, printing and meeting expenses. It also includes memberships to L.A. County Federation of Labor (LA Fed), Marine Engineers Beneficial Association (MEBA), Coalition of California Law Enforcement Associations (CCLEA), Southern California Association of Law Enforcement (SCALE), California Peace Officers Memorial Fund (CPOMF), Coalition of County Unions (CCU) and California Contract Cities (CCCA).

#### Membership Expenses

Membership Benefits are expenses related to events/activities (Family night, Baker to Vegas, Awards Banquet, Summer Games and Memorial Events), trainings and seminars, materials (including membership communications like the Dispatcher, newsletter, e-mail blasts, website, social media, and ALADS App), meetings (salary contract negotiations, PEC, unit rep, and facilities), community outreach and retirement plaques.

#### PAC Contribution

This account is for supporting or opposing candidates in various city, county and state elections.

#### Professional Services

Professional Services are consulting services related to public relations, accounting and auditing, investment, witnesses, experts and investigations.

#### Goodwill and Welfare

This expenditure provides funding for sponsorships to support department events, military leave dues, the Sheriff's Relief Fund, scholarships and member activities.


#### Legislation


Since its inception in 2014, the ALADS C.A.R.E.S. Foundation has donated nearly \$2 million to members and their families in need.





## **ALADS Will Work to Educate and Communicate with Lawmakers**

The action at the State Capitol in Sacramento is in full swing; due to legislative deadlines, legislators have now been forced to reveal the framework of their respective bill packages for the year. 2022 is the second year in the two-year legislative session, leaving limited time to negotiate or slow-play complex or controversial issues. Measures that stall this year will not have opportunity to move after the Legislature adjourns in the late summer.

By the last day to introduce bills for the 2022 California Legislative Session, there

was a total of 2,020 bills introduced between the Senate and Assembly, including 1,461 bills introduced during the last week alone. Of the 2,020 total bills introduced, there were 1,361 Assembly Bills and 659 Senate Bills.

In the spirit of "see a headline, see a bill," we have tagged numerous measures related to the recent crime wave that has saturated the headlines for months. Constituents have been extremely vocal that public safety is a now a priority in 2022. The surge in organized retail theft, "smash and grab" robberies and prosecutorial limitations established by Proposition 47 have generated nearly a dozen different bills to strengthen the law. Adjustments to laws governing fentanyl and sale and manufacturing of the deadly drug are in print. Meanwhile, a dozen catalytic converter theft measures have been simultaneously introduced. Thus far, it remains unclear if any of these bills will move into law, but the volume of measures in play is striking.

The overall subject matter of the legislation we have reviewed and

referred to the Association has been somewhat conservative and cautious in nature, at least compared to past years. There are a number of reasons for this general trepidation including redistricting. The new map has forced lawmakers to take a more careful approach as they familiarize themselves with their new constituents.

Members are also staring down a massive exodus due to term limits that will largely turn over the entire Assembly, as we know it, between 2024 and 2028. More than a dozen California lawmakers have also declared candidacy elsewhere in State and Local government. At last count, 26 Assembly members and state senators have either opted not to seek re-election in 2022 or have already quit mid-term. That doesn't include the seven members, all senators, who are barred from seeking reelection in 2022 by term limits; nor does it include several members who are hoping to jump from the Assembly to the Senate.


The dynamics are not limited to one party: So far, out of 120 total members, 25 Democrats, 7 Republicans and one independent are not coming back next year. This is going to trigger a massive re-education and networking effort by the Association to ensure that incoming Legislators understand the nuances of your priorities as well as the background on recent and historical battles from the past years that may resurface due to the exit of institutional knowledge.

While there appears to be a lull in the storm compared to recent history, we know that it is critical to remain vigilant, responsive and active in educating, communicating and building relationships with our elected officials. Many of the bills we are seeing in 2022 are results of overreaches in past years that are now requiring correction. We can be partners in crafting the necessary balance.

As the year rolls on, we will continue to actively advocate for your priorities and ensure that your voice is heard in Sacramento.



James Bozajian is an ardent

Measure J publicly and vigorously.
"I campaigned hard against Measure J and
Measure J was overwhelmingly rejected in
Calabasas and the surrounding Conejo Valley

cities of Agoura Hills, Hidden Hills, and Westlake Village."

"Its passage was highly disappointing on both a personal and a professional level. Fortunately, the Courts invalidated Measure J."

An attorney by profession, Council Member Bozajian has served the people of Los Angeles County as Deputy District Attorney in the Los Angeles County District Attorney's Office for 24 years. He is currently employed as an Attorney for State

Compensation Insurance Fund.

The State of California has increasingly weakened its criminal statutes to the point where many offenses have essentially been de-criminalized. "I feel this has been a disservice to Californians. I often get the sense that those who work in law enforcement --- police officers, prosecutors, corrections officials, probation officers, and others --- are

not given the appreciation they deserve."

"Some of the more obvious impacts of this direct assault against law enforcement will be to trigger severe budget cuts, stretch already-limited resources to a dangerous extent, and cripple morale among rank-and-file deputies. I often worry that we are on the cusp of a very large crime wave, to which we will have far fewer resources to respond."

Council Member James Bozajian has served on the Calabasas City Council for 25 years. He was first elected to the City Council in 1997 and has served as Mayor six times. Calabasas is the "youngest" of the 88 cities in Los Angeles County, having incorporated on April 5, 1991 – just a few months before the opening of the Lost Hills Sheriff's Station here in town, "I was the first new City Councilmember elected since

incorporation. Because I came on board during the city's fledgling years, I have had an opportunity to help shape the growth of our city's infrastructure pretty much from the ground up."

Born and raised locally, Council Member Bozajian has witnessed the City's growth. In the past three decades, Calabasas has nearly doubled in population, and many new businesses have come to serve

> our growing community. These changes have brought with them some additional challenges to maintaining public safety, "I think our community most appreciates those aspects of law enforcement services that emphasize the personal touch. Personally, I believe it is a good idea to keep the same deputies working with Calabasas for longer time periods in order to establish and maintain a good rapport with the community. I have been particularly impressed

with the level of care, concern, and sensitivity the deputies have shown to those most vulnerable. There are so many downsides to the COVID-19 pandemic. However, I have noticed greater personal interaction between deputies and those who live and work in Calabasas. It is refreshing to witness some closer bonds developing between deputies and civilians."










# ALADS & PPOA Hold Sheriff Candidates Forum

**Tradition. Honor. Service.** Values that echo through time. Become a part of this proud legacy that honors our brother and sister officers and military personnel by joining the Los Angeles Police Emerald Society Pipes and Drums.

**Tradition.** Bagpipes have a long, proud history with the law enforcement community and the military. When the Romans invaded Latin Britannia (England) in 400 BC they were frightened by Celts playing a form of the bagpipes going into battle. The Romans later incorporated bagpipes into their own legions.

During the Great Potato Famine of the 1840s, large numbers of Irish immigrants coming to the United States brought with them the bagpipes. Facing mass discrimination, the only jobs available to the Irish at that time were in the police and fire forces...and so the symbol of the bagpipes became forever associated with law enforcement.

Bagpipes came to the Los Angeles Police Department on May 5, 1958, when Ian Campbell entered the Los Angeles Police Academy. Being of Scotch-Irish descent, Ian started playing the bagpipes as a teenager. He continued to play while in the Marine Corps and during his career with LAPD. While on duty in March 1963, Ian and his partner, Karl Hettinger, were kidnapped at gun point, and

taken to an onion field south of Bakersfield where lan was executed. Karl managed to escape. Bagpipes were first played at an LAPD funeral at lan's service — a tradition that continues to this day.

Honor. Members of the Los Angeles Police Emerald Society Pipes and Drums continue to preserve the proud tradition of the bagpipes by honoring heroes from law enforcement and the military. We are not a competition pipe band. Our purpose and mission is to honor those who have made the ultimate sacrifice. We are a multi-agency Band. We play for the Los Angeles County Sheriff's Department and all law enforcement agencies in Southern California. We have traveled to multiple states to honor our brother and sister officers as well as the military. Every year, we play in Sacramento at California State Memorial Ceremonies and in Washington, D.C. during National Police Week.

Recently while playing in Washington, D.C., the Band was approached by the wife of a police officer who had been killed in the line of duty. Her husband loved the bagpipes and wanted to have them played at his funeral. Unfortunately, a bagpiper was not available at the time of his service, so his request was unfulfilled. When she saw us, she asked we play "Amazing Grace" for her husband — which we

gladly did. On that trip, officers at a pub in Washington, D.C. were remembering Arkansas Fort Smith Police Officer Daniel Martinez who had been shot and killed while handling a family dispute. They asked us to play "Danny Boy" in his memory. While we played, everyone gathered and held up lighters and candles in his memory. Both experiences were spontaneous and very emotional.


