

In my 13 years as a deputy sheriff, I've never asked ALADS for help before. I have had close calls (like most patrol deputies) in the field, but I was always able to somehow explain my actions. I didn't understand how important being a member of this massive police union really is, until I reached out for help on behalf of a friend.

What Does It Mean to be an ALADS Member?

Like many of my partners past and present, I walked outside of the ER, called the ALADS I've seen my share of violence in the field. As a 15-year veteran of the U.S. Army Special Operations with several deployments, I've witnessed death more times then I care to remember. It is impossible to express in words how difficult the task is of bringing home a fallen soldier, and fellow Green Beret, to his family from the battlefield. I thought that mission would be the hardest mission of my life. I was wrong . . .

Two weeks ago, I received the worst phone call of my life. In the middle of the night, I was informed that the child of one of my closest friends / partners tragically lost her life in a horrible accident. My partner has been a deputy sheriff for many years, and has proved herself working tough assignments throughout her career. She never once asked me or anyone for help during our time on the department. She is the hardest deputy I know. She never complains, never accepts special treatment, and always handles her business. We went through Force Instructor School together. So far, it was the hardest training I've done in law enforcement. Of course, my partner was the only female. She was fighting men without issue. I view her as this strong, tough, street cop. I was shocked when I received the phone call regarding the loss of her child. My heart sank into my chest and I immediately thought of the pain she must

I drove to the E.R. and spent the night with her and her family. The look in her eyes said it all. I've never seen something so horrible in my life. I witnessed a loving mother lose the most valuable possession she will ever hold in her hands. I felt helpless to console her as she struggled with the loss. As she cried in my arms I kept thinking, "How can I help this situation?" "What can I do to better this situation?"

main phone line and spoke with Sandra Villagran. I didn't even know what I was asking for. After speaking to her for several seconds, I informed her of the situation. I asked her for any assistance ALADS could provide during this time of emergency. Sandra told me something I will never forget. . . She told me about the ALADS C.A.R.E.S. Program and would forward my request for assistance to Lucy Hayhurst (who also is an ALADS employee). Sandra told me through the program ALADS might be able to cover the cost of the funeral services.

I went back inside the E.R. armed with this newly found knowledge. The timing wasn't right, I decided to wait until the situation calmed down to tell my partner of the possible relief service. After several horrible days of comforting my partner through the darkest days of her life, I received a phone call from Lucy as promised by Sandra. She told me, ALADS approved the funding for the funeral services through the ALADS C.A.R.E.S. Program. I walked back inside my partner's residence and told her ALADS was willing to cover the cost of the funeral. She looked into my eyes, her eyes watering. She simply said, "Thank You." It was the first time I felt I actually helped the situation.

I was relieved she had one less thing to worry about. I was so grateful for the special people at ALADS who worked so quickly to provide relief for such a tragic event. I called Sandra and Lucy back to thank them for their dedication and hard work in providing services to the members of LASD. I realize now what it means to be a member of ALADS. It's much bigger than a police union, it's a family. I will be forever thankful.

Happy One Year Anniversary ALADS Legal Defense Fund

It's been a year since the ALADS Board of Directors created and adopted the Plan Document for the ALADS Legal Defense Fund (LDF). The plan was created as a collaborative effort from our very well-respected attorney, Russ Richeda, our Executive Director Derek Hsieh and the ALADS Board of Directors to meet the specific legal needs of ALADS members. I would put the ALADS LDF plan up against any legal plan in the country. We have four law firms, Raines Lucia & Stern, Charles Goldwasser & Associates, Stone Busailah, LLP and The Gibbons Law Firm, with access to more than 60 lawyers.

The LDF is **exclusive** to the ALADS membership and is administered by the ALADS Board of Directors. This means that the decisions on all cases **are decided by your fellow deputy sheriffs**, not an outside entity, who may or may not have a law enforcement background or the members' and ALADS' best interests in mind.

The LDF covers administrative, civil and criminal representation for complaints or investigations arising from the course and scope of your duties. The plan also covers civil monitoring when the county is providing a defense for a civil lawsuit. ALADS members also receive a one-hour free consultation for legal issues outside of the scope of the LDF plan.

Last year, the LDF received more than 800 requests for representation for administrative and criminal investigations, civil monitoring, and legal consultations. Some of the reasons for the requests were for: uses of force, inmate deaths, deputy involved shootings, policy of equality violations, traffic accidents, alcohol-related incidents, and off-duty incidents.

Additionally, the LDF is used for representation and litigation at civil service hearings, grievances, and arbitrations for members at the Employee Relations Commission (ERCOM). ERCOM is where Los Angeles County employees are required to have their grievances heard

before a panel of three commissioners (The Commission). The commissioners then decide to either deny or recommend the grievance based on preliminary evidence before it goes before a hearing officer. If the Commission sends the grievance before a hearing officer, the hearing officer will listen to the arguments and submit a report back to the Commission. The Commission decides the case based on the hearing officer's report in the affirmative (win) or in the negative (loss). Both sides then have an opportunity to accept or appeal the decision to the Commission. If there is still no remedy, both sides have the option of taking the matter to superior court. ALADS has taken cases to the superior court and all the way up to the California Supreme Court for our members.

Why is the LDF so important to you? Everyday, deputies and district attorney investigators are taking law enforcement actions. Unlike in the movies, enforcing the law in real life, especially if force is used, is never pretty or glamorous. Your actions are scrutinized by the department, the OIR, the Citizen's Commission on Jail Violence, County Board of Supervisors and finally the public. The LDF ensures that if you are involved in an incident that falls under the course and scope of your duties and action is taken against you, you will have excellent legal representation protecting both your career and your finances. Attorney's fees for cases can range from \$10,000 up to nearly a \$1,000,000. The cost can destroy a deputy's finances and put their family in jeopardy. The LDF helps to protect every ALADS member against this catastrophe.

Finally, the LDF is a constantly evolving Plan Document created to meet the ever-changing needs of our membership. Rest assured, your Board of Trustees is always looking for ways to improve the LDF for members and will continue to do so into 2020.

ERCOM Meeting Update

One of the matters discussed at ERCOM's monthly regular session meeting on January 28, 2019 was the remedy ordered by the Hearing Officer in the Guidelines for Discipline UFC, already won by ALADS. The Commission adopted 4 out of 5 of the Hearing Officer's ordered remedies including an order that the department revert to the 2012 Guidelines for Discipline and that the department must meet-and-confer with ALADS on any changes they seek to make to the Guidelines. The sole remedy that had not been adopted yet was for the department to make any member negatively impacted by the unilateral implementation of new discipline guidelines, to be made whole. The reason for the delay was due to the department's claim that it does not keep discipline records and does not know which deputies have been impacted. ALADS took on the task to compile the data from members who received discipline from 2012 to present.

Secret Records of Police Misconduct Must be Released

ALADS strongly opposed SB 1421 and once the bill was passed, we took our fight to the courts to ensure it wouldn't be applied in unlawful, unauthorized ways. The L.A. County Superior Court ruling stated that it is legally acceptable for SB 1421 to be retroactive. ALADS continues to fight and protect its members, especially deputies who were accused of wrongdoing and made career-altering decisions about whether to appeal their discipline based on an understanding that their files would remain confidential. ALADS fought SB 1421 all the way to the California Supreme Court. We were the only Peace Officer Association (POA) to fight it to conclusion.

ALADS likes to ensure the safety of its members to prevent drunk driving incidents at fun events, such as Baker to Vegas. ALADS offered refunds to members who use Lyft and Uber during Baker to Vegas weekend.

ALADS' Statement to Members Regarding the Media's Coverage of the Department

- All of us, especially elected officials and members of the media, would do well to remember that peace officers are entitled to certain rights, and that these rights are no less important than that of any individual or group.
- We are disappointed by the actions of the L.A. County Board of Supervisors who have engaged in a highly politicized attack on the Sheriff and focused on an individual case at the expense of other important public safety policies and decisions – such as addressing our dangerous deputy shortage.
- ALADS will always work to ensure that due process is followed, that deputies are treated fairly in any disciplinary proceedings, and that appropriate processes and confidentiality are in place as cases are resolved.

ALADS continues to be focused on the big picture, to advance the efforts of Protect California, while working to mitigate the damage caused locally by excessive political battles and unfair media coverage.

ALADS' FLSA Lawsuit Update

The lawsuit was assigned to United States District Court Judge Dale Fischer, who has established a pre-trial and a trial schedule for the case. Trial will likely be held in mid-2020.

The County and the Plaintiffs have agreed to settlement talks and have engaged retired federal court judge Dickram Tevrizian as a mediator. If the mediation did not produce a settlement, a notice would be sent to approximately 76,000 overtime-eligible county employees in early May 2019. Once the notice was sent, employees had 120 days to join the lawsuit.

Approximately 1,750 attendees came out to support the Homicide Bureau & ALADS Baker to Vegas Barbecue.

URGENT! ACLU Use of Force Bill Headed to Committee Hearings

ALADS asked its members to take action to stop the use-offorce bill, AB 392, from passing the State Assembly's Public Safety Committee hearing held on April 9th. AB 392 was initially written to make it easier to criminally prosecute public safety officers who are forced to make split-second decisions during dangerous encounters.



ALADS, Protect California and SB 230 Author Senator Anna Caballero Announce Major Amendments to California Use of Force Bill

ALADS, members of the Protect California coalition and Senator Anna Caballero made amendments to SB 230 with the feedback that they received from the Attorney General, legislators and community leaders throughout the state. With the amendments, SB 230 now:



- Establishes the first statewide guidelines to clearly define when officers are authorized to use force.
- Requires that every California law enforcement officer received the most robust training in the nation strictly designed to minimize the use of force.
- Sets specific policy requirements on de-escalation, rendering medical aid, proportional use of force and more.
- Sets forth detailed, standardized requirements for reporting all instances when force is used in our communities.
- Specifies that use of force policies and training are considered in legal proceedings.
- Strengthens the California Penal Code's definition of justifiable homicide for peace officers.

Fringe Benefit Contract:

Coalition of County Unions Reaches Tentative Agreement of Fringe Benefit Contract

After more than a year of bargaining, the Coalition of County Unions (CCU), which ALADS is a part of, reached a Tentative Agreement (T/A) with the County of Los Angeles on a successor Fringe Benefit Memorandum of Understanding (MOU). After face-to-face meetings with members of the



Board of Supervisors, the Coalition ultimately was able to reach an equitable agreement that included a \$500 bonus, a full paid holiday (8 hours), and an early implementation of the 2nd year increase to health contributions!

Peace Officer Day at the State Capitol

ALADS sponsored 50 deputies and district attorney investigators to fly up to Sacramento for the first-ever "Peace Officer Day" at the Capitol on Tuesday, May 28. ALADS was instrumental in creating Peace Officer Day which allowed peace officers and their families from around California to stand together, meet with legislators, and discuss how AB 392 threatens peace officers' lives and the lives they protect. Thank you to Assemblymember Jim Cooper who spoke to all of the POAs at the first Annual Peace Officer Day at the State Capitol.





AB 392, What Does it Mean?

ALADS fought a long hard battle against AB 392 and in favor of SB 230. Both bills passed overwhelmingly. ALADS' battle with legislators in Sacramento to defeat AB 392 made them modify the original language and insert language consistent with Graham v. Conner. The bill's final language was the product of the work done by ALADS, with the assistance of long-time public safety attorney Will Aitchison, and our partner organizations. Due to ALADS' strong stance and the change to the bill's language, many of the bill's original supporters abandoned it after they felt law enforcement was victorious in defeating it. ALADS President Ron Hernandez was quoted in an LA Times article regarding AB 392. "Leaders from our union and decision makers in Sacramento have come to an amenable agreement on AB 392 that prioritizes the safety of our deputies while updating our California laws to reflect our best practices. The dangerous definition of 'necessary' is no longer in the bill and the requirement to exhaust all alternatives has been stricken. Our message and our concerns were heard."

Governor Newsom Signs Legislation that Codifies Current Use-of-Force Standards Utilized by Major Law Enforcement Agencies Throughout California

On August 19th, Governor Gavin Newsom signed legislation, AB 392, that mirrors policies and procedures that govern public safety officers' use of force in California. The new state law's standards codify those currently utilized in Los Angeles, San Francisco, San Jose and other major law enforcement agencies throughout our state. These current standards emphasize deescalation of volatile situations and a reverence for life.

The signing of AB 392 into law reinforces the dire need for the passage and funding of SB 230 (Caballero), which will provide California public safety officers critical mental health, continued de-escalation, and other necessary training on an ongoing basis to improve officer and community outcomes.

The department conceded to a resolution of any outstanding disputes for Field Training Officer pay for three month increments, including Field Training Officers that have worked only one day of each pay period.

Saugus High School Shooting

On November 14th, deputies were called to Saugus High School due to reports of a shooting on campus. Off-duty LASD Detective Daniel Finn along with Inglewood PD Officer Sean Yanez and LAPD Officer Gus Ramirez were first on the scene within seconds of the shooting. School resource Officer James Callahan was on scene in a matter of moments. Uniformed deputies from Santa Clarita Station arrived within a minute. Two students, 15-year-old Gracie Anne Muehlberger and 14-year-old Dominic Blackwell, were killed and three were wounded in the shooting. The shooter, 16year-old Nathaniel Berhow, took his own life. Of the actions of members of law enforcement, Sheriff Alex Villanueva said, "Offduty first responders were there and did not hesitate, turned around and went right into the source of the gunfire to attempt to neutralize it, and they rendered first aid immediately," he said. "Their actions definitely saved lives, and my hat's off to them."

FLSA Lawsuit Settled

The lawsuit arose of the County's non-compliance with the Ninth Circuit's decision in Flores v. City of San Gabriel, where the court held that cash in lieu of health insurance benefits had to be included in the calculation of the FLSA's overtime rate. In July 2018, in an attempt to head off the lawsuit, the County recalculated overtime including the cash-in-lieu and paid employees what should have been paid in the first place, but only back to January 2018. Since the FLSA has a threeyear statute of limitations, the County's payments were clearly inadequate and the lawsuit was filed.

In August 2018, after the lawsuit was filed, the County recalculated overtime again and made a second payment, this time going back to August 2015. However, the County's payments did not include double or "liquidated" damages, usually required by the FLSA. And so, the lawsuit continued.

What Does The Settlement Provide?

The County has now agreed to pay liquidated or double damages in an amount equal to the two 2018 payments it made to employees. This means that all Plaintiffs will have received everything they were due under the FLSA, including three full years of damages plus liquidated damages.



ALADS Continues to Make Certain that Our Voice is Heard and is Making an Impact in **Public Policy Decision-Making**

The Association for Los Angeles Deputy Sheriffs entered the 2019 Legislative Session prepared for a full-frontal attack on the law enforcement profession; and the interest groups pushing the anti-peace officer agenda did not pull any punches. Our typical battles deal with the wages, working conditions, and safety issues for deputies; but one bill in particular directly attacked a peace officer's right to defend their own life and the life of others in danger.

In a fight that carried over from the prior Legislative Session, Assembly Bill 392

(Weber) was a re-introduction of Assembly Bill 931 (Weber). Law enforcement unions came together to grind AB 931 to a halt in the Senate in 2018 through a relentless advocacy effort that consumed the State Capitol in Sacramento while following Legislators home to their Districts through targeted education campaigns and "boots on the ground" visits to Senators and Assemblymembers in their communities. The fight spilled into social media, radio ads, television spots and national publications who were closely tracking the ebb and flow of the fight on "use of deadly force" in the State of California.


While we were successful in stalling the measure in the Senate prior to a Floor vote, effectively killing it for the year; the Author, Legislative leadership in both Houses and the newly elected Governor all made it clear that "something" was going be adopted to update California's antiquated Codes policing an officer's use of deadly force. Knowing this, law enforcement came together once again to spearhead a proactive measure in Senate Bill 230 (Caballero) to require uniform "best practices" with local policies regarding use of force. The measure also

contained funding and directives for increased and targeted training for peace officers.

Despite the emotional grind of the battle over AB 392 and SB 230, the end result was productive and favorable to peace officers by updating the Penal Codes to reflect decades of case law and findings related to use of deadly force, fleeing felon laws and others. The measures were enacted into law on January 1st.

While engulfed in the use of force battle, ALADS also engaged in numerous other efforts on behalf of deputies. ALADS was a presence in the debate whether counties should have a third-party Sheriff's Oversight Commission with subpoena power. AB 1899 (McCarty) was pulled from a vote on the Senate Floor as it fell short on votes. The Association was also active in stalling bills to extend the hours of alcohol sales to 3 am, and measures to allow for the establishment of legal intravenous drug injection sites. We went to battle on bills involving removal of sentence enhancements for repeat offenders; amendments to the Pitchess process; and prohibitions to emerging technologies that law enforcement desperately needs.

With the composition of the Legislature in a historically lop-sided majority; the "super" majority party Democrats will continue to explore pushing the envelope on public safety issues, criminal justice reform, sentencing reductions and alternatives to incarceration in favor of rehabilitation. There have been a steady stream of bills to swing the pendulum further and further in the progressive direction. Your board and advocates will continue to speak on behalf of victims and ensure that our constituents feel safe in their communities and especially in their homes. In the meantime, we will be working to make certain that the voice of ALADS and our members is always at the table and making an impact in the way public policy is shaped in California.

Legal Services

Operating Services and Supplies

Membership Expenses

Membership Benefits are expenses related to events/activities (Family night, Baker to Vegas, Awards Banquet, Summer Games and Memorial Events), trainings and seminars, materials (including membership communications like the Dispatcher, newsletter, e-mail blasts, website, social media, and ALADS App), meetings (salary contract negotiations, PEC, Unit Rep, and facilities), community outreach and retirement plaques.





In Memory of Detective Amber Leist

EOW: January 12, 2020

etective Amber Leist, 41, will be greatly missed by her family, friends and coworkers. On January 12, 2020, Detective Leist tragically lost her life assisting two people in need while they were crossing the street.

Amber was in her vehicle stopped at a stoplight when she witnessed an elderly woman trip and fall inside of the crosswalk. An elderly man was struggling to get his wife up off of the ground. She knew that without her assistance, when the light turned green, the elderly couple could be struck by passing vehicles in the heavy traffic. In a selfless act, Amber got out of her car and went to the aide of the couple attempting to cross the street. Right before entering her vehicle, the traffic light turned green and an oncoming vehicle traveling eastbound on Riverside Drive in Valley Village fatally struck Amber. The driver of the vehicle tried to give Amber aide and cooperated with the authorities in the investigation.

Detective Leist was taken to Cedars-Sinai Medical Center where she succumbed to her injuries a few hours later.

Amber's captain at West Hollywood Station, Edward Ramirez, was not surprised that Amber's final deed was assisting an elderly woman in distress. At the memorial service, he told numerous stories about Amber's selflessness and caring about others. For example, when Detective Leist, Captain Ramirez and a car loaded with her fellow detectives were going to training in an











unmarked vehicle, Amber spotted a stranded motorist in a stalled vehicle. The motorist had the look of serious concern on their face. Detective Leist immediately ordered everyone out of the vehicle to assist the stranded motorist by pushing the vehicle to

the side of the freeway shoulder, out of harm's

Member. After she graduated from the North Academy Class 362, Detective Leist was assigned to work at the North County Correctional Facility. Sheriff Villanueva said that people began to recognize the type of person that Amber was while she was stationed there. She would take care of her partners, especially when they were drafted for the two or three overtime shifts a week by preparing them meals, such as egg salad sandwiches and gumbo. Amber was a foodie and loved making gumbo. If you did not like gumbo, Amber would try to change your mind by making you try it no matter what.


In April 2012, she was assigned to patrol at Lancaster Station where she went through the field training program. At the memorial service, Sheriff Villanueva shared a story that one of her training officers told him. While learning how to drive Code 3 for the first time, the training officer noticed Detective Leist showed some signs of tunnel vision. To help her pull out of it, he made her belt out "Twinkle, Twinkle Little Star," which worked. After she finished her training, Amber worked in the field and became a school resources officer which allowed her to touch the lives of students and participate in school activities like reading to the children in class.





In 2015, Amber transferred to West Hollywood Station where she would later be promoted to detective. She was very active at her station and received numerous commendations for all her hard work and dedication on the department. Her family, friends and colleagues spoke about her wonderful people skills during the memorial service. Amber was one of those people who could start a conversation with strangers, or even suspects, and make them feel like they were one of her friends. Whenever she was the first person to arrive at a gathering, friends would always see her talking to someone and being in deep conversation. They would ask her who the person was. Amber's response, "I do not know. We just met." Detective Leist could identify a fake person a mile away and if you tried to press her too aggressively, she would let you know in her own way. Each day at West Hollywood Station, Amber would make her rounds throughout the station asking how everyone was, about their weekend, their family and loved ones, old or new love interests or a new restaurant she discovered.


Captain Ramirez stated that Amber had her fair share of male fans. One in particular,



There are countless stories of Amber's adventurous self, heroism and dedication to serving others. Detective Leist was one of a kind. Her sister, Heather, said of Amber, "You could be incredibly stubborn and tough as nails but in the same token your heart of compassion was simply too big for your body. The passion that you had, the dedication and loyalty you upheld to the people and things that you loved the most was simply undeniable." Amber's untimely death has left a void at the West Hollywood Station and in those who she had impacted in their lives. Through the memories of her family, friends and coworkers, Detective Amber Joy Leist will never be forgotten.

Detective Leist's memorial service was held at Mosaic Church in Hollywood on January 25th with hundreds of attendees to pay their respects to her and her family. She was laid to rest at Malinow & Silverman Mortuary in Covina. Detective Amber Leist is survived by her parents, Daniel and Ellen; her sisters, Savannah, Sumry and Heather; and her two sons, Daniel and Ray. Ray is currently serving active duty in the U.S. Navy.

In the weeks following Detective Leist's death, the ALADS C.A.R.E.S. Foundation raised \$22,354 for her family. Thank you to everyone who made a contribution.



n November 25, 2019, Deputy Dakota Palanca, 25, responded to a call regarding a man acting erratically in the parking lot of a local shopping center in Paramount. According to authorities, the erratic man ran to Deputy Palanca's patrol car window and immediately started assaulting her before running off. Deputy Palanca was on a foot pursuit after the suspect when she was struck by a suspected drunk driver in a SUV, critically injuring her. Both men were apprehended shortly after this tragic incident took place. As of when this article was written, Deputy Palanca, who was originally taken to Saint Francis Medical Center, continues to recover and is in stable condition.

Deputy Palanca comes from a law enforcement family. Her stepfather, Rick Hayden, recently retired as an Azusa police lieutenant and her mother recently retired as

a corporal of the West Covina Police Department. She graduated from Cal State Fullerton with a degree in Psychology and told her family that she would like to become an officer too. This shocked them because she excelled in a mock trial at her high school and believed that she would become an attorney instead of a law enforcement officer. By the age of 23, she graduated from college, was a second lieutenant in the Army National Guard and a deputy sheriff.

Deputy Morgan Arteaga told the *Press Telegram* that deputies who work with Palanca have come together to assist the family during this time in need. They have brought food for her family and stayed by Palanca's bedside so her family could take breaks and to keep guard of her room so unwanted visitors cannot enter. ALADS and Lakewood Station joined forces and raised more than \$35,000 for Palanca between December 11, 2019 to January 11, 2020 to assist with her family's travel expenses, medical expenses and help take care of several horses she owns while she is in the hospital.

It is going to be a long road ahead for Deputy Palanca. About one and a half months after the incident, Palanca has been making some progress by breathing on her own with little assistance from a ventilator. She has not been quite able to speak but can almost say small words and show her motions through moans. She is also doing physical therapy each day. At a fundraiser held for Palanca in December, her stepfather said as soon as she gets better, "we're going to train her up and get her back to the Lakewood Station so she can continue defending the public." All of us wish Deputy Palanca a full recovery.

ealing with an unresolved healthcare claim can be one of the most stressful and frustrating situations you will experience in your lifetime. There are steps you can take to limit your exposure to this aggravation but sometimes you can try to do everything right and still experience a denial of a claim for benefits or end up with unexpected out-of-pocket expenses.

There are numerous reasons that can cause a denial or reduction of benefits. Some can be easily cleared up, while others can require more work to get resolved. For every visit to your healthcare provider, a claim for benefits is filed with your health insurance carrier. After the claim is filed, the carrier determines what benefits are due and produces an Explanation of

Benefits (EOB) that is mailed to your home.

Reviewing the EOB is important as it contains the details of how a claim for benefits was processed and whether or not you have some financial responsibility in the matter. If after reviewing the EOB, you believe it was not processed correctly, you may be right. Several things could be affecting the claim processing result, such as the provider needing to submit further information or the carrier could be waiting for a reply to correspondence sent to you. Periodically, the insurance carrier will mail you requests to update your insurance status with them. This is done to see if a coordination of benefits applies in your situation. Other times, procedure codes used by your doctor trigger the carrier to question if the treatment sought by you was due to an accident where another could be financially responsible for the treatment. To avoid claim processing delays, be sure to open all correspondence from the carrier and respond timely to any requests for information.



ALADS Hosts the First Event for the Department's Contract Cities and First Good Samarftan Awards

wo firsts were celebrated at an ALADS event on Nov. 7. A first ever dinner gathering was hosted for the department's contract cities, and three private citizens were recognized with the first ever Good Samaritan award.

Mayors, city council members and other officials from 22 cities stretching from Palmdale to Rancho Palos attended the dinner and heard remarks from Los Angeles Sheriff Alex Villanueva.

The attendees also applauded the men who came to the aid of Deputy Gerardo Alcaraz who was fighting for his life during a scuffle with a man who was trying to grab his gun.

It happened in South Whittier last August when one of the good Samaritans, 51-year-old Paul Landino, was in his car with his family and saw the fight unfold.

"My wife said someone is going to get shot. If you are going to do something, do it now. So I acted. I felt I had to," he said. "It opened my eyes to the hate people have for police officers. But people don't understand what they go through on a daily basis. People don't understand the level of stress they are under every day."

Paul Landino, Jose Pineda and Brian Whitney helped detain the suspect before backup support arrived on the scene.

Two of the three men who attended the ALADS dinner received a folded American flag with a plaque.

Paul Landino's award sits on a mantel at his

"The award means a lot," he added. "Would I do it again? Absolutely."

In addition to these two events, the dinner audience also got a snapshot of what's to come in next year's ballot box. Officials from



Sacramento talked about a proposition called "Keep California Safe Act of 2020". The measure is an effort to expand the list of violent crimes in our state and to allow the collection of DNA for certain misdemeanor crimes. Currently, rape of an unconscious person, trafficking a child for sex, assault of a peace officer and other crimes are not listed as violent felonies. That makes criminals

eligible for early release.

"The evening was a huge success for us," said ALADS President Ron Hernandez. "We created this opportunity for us to host this event on neutral ground, based on our agenda, so that the Sheriff, his command staff and contract city officials could talk in a relaxed setting about what is important to all ALADS members, public safety."

MODIFIES 1MBs 2018-02 AND 2018-16

<u>ISSUE</u>: Is there a "community caretaking" exception to the warrant requirement for police <u>entry</u> into a private home?

There are **four** lawful ways for police to enter private homes (search or arrest **warrant**, valid **consent**, residential search term of **probation/parole/PRCS/supervised release**, or one of the recognized categories of **exigency**. (See 1MB 2018-16.)

As indicated in 1MB 2018-02, "there is **considerable confusion** as to when the 'community caretaking' doctrine applies, and as to its proper application" (citing as one example the three varying opinions in *People v. Ray* (1999) 21 Cal.4th 464).

The California Supreme Court has now declared that while "community caretaking" may justify certain **vehicle** searches, it is **not an exigency** that justifies warrantless **home entry**:

"We conclude that an entry for reasons short of a perceived emergency, or similar exigency, fails to satisfy the relevant constitutional standard. We disapprove the lead opinion in People v. Ray, to the extent it conflicts with the views expressed here." People v. Ovieda (2019) ____ Cal.5th ____, No. S247235, Slip opn. at p. 1.

• Police were called to the home of Willie Ovieda, where he was reportedly suicidal, with access to firearms. After their arrival, Ovieda and two friends came outside. Officers searched and cuffed Ovieda. The friends told officers they had collected the firearms and put them in the garage, and no one else was present inside. Officers entered "to do a protective sweep" and to be sure there was no one else inside who might be armed, injured or in need of aid. Drugs and illegal weapons seen in plain view were seized, and Ovieda moved to suppress all evidence resulting from the warrantless entry.

Both the trial court and the Court of Appeal denied suppression, finding that entry was justified by the "community caretaking" exception. The California Supreme Court has reversed, ruling that **as to residential entries**, "No such exception exists, and the Ray lead opinion was wrong to create one." Id., Slip opn. at p. 10.

• If entry into Ovieda's home could not be justified by "community caretaking," how about the "emergency aid" exigency? The unanimous opinion in *Ovieda* does acknowledge that "police do not need ironclad proof of a likely serious, lifethreatening injury to invoke the emergency aid exception" to justify immediate entry, but "officers must possess an objectively-

reasonable basis for believing that an occupant was seriously injured or threatened with such injury" before making entry. *Id.*, Slip opn. at p.18.

Because the officers in this case had no reason to disbelieve defendant's friends' assurances that no one else was inside and that the firearms had been removed to the garage (and because Ovieda could have been lodged 5150 and a warrant sought for his guns), the court found that any emergency-aid rationale could be based only on speculation— not on any objective facts. "[T]he objective facts that elevate speculation to reasonable suspicion were not present or were not articulated at the suppression hearing." Ibid.

<u>BOTTOM LINE</u>: "In sum, the community caretaking exception asserted in the absence of exigency is not one of the carefully delineated exceptions to the residential warrant requirement recognized by the United States Supreme Court." Id., Slip opn. at p. 24.

<u>ISSUE</u>: What are the ramifications if law enforcement officers impose *conditions* when seeking a *Miranda* waiver from a suspect?

Three principles of interrogation case law may be implicated by the manner in which a suspect waives *Miranda* prior to custodial police interrogation.

(1) Valid waivers may be express or implied.

Miranda waivers are express when, after a full warning and the suspect's acknowledgement of understanding, the suspect is pointedly asked if s/he wants to talk, and s/he makes some affirmative response. Waivers are implied if, e.g., after warning and acknowledgment, the suspect answers an engaging, non-threatening question and continues to answer questions. Implied waivers have the advantage of being less likely to provoke an invocation, and they are legally acceptable to satisfy Miranda. Berghuis v. Thompkins (2010) 560 US 370, 384. (See 1MBs 2008-18, 2010-09.)

Attempts to obtain *express* waivers, on the other hand, have the **disadvantage** of being more likely to prompt a suspect to invoke, thereby **inhibiting** the truth-seeking purpose of an investigation. *Oregon v. Elstad* (1985) 470 US 298, 309. Questions designed to obtain express waivers also run the risk of being inartfully phrased in such a way as to **create conditions** that may limit subsequent interrogation.



If a suspect's waiver is **conditional**, the admissibility of subsequent statements depends on whether interrogating officers honored any condition. *Connecticut v. Barrett* (1987) 479 US 523, 529 (where suspect **conditionally waived** by agreeing to talk, but not to put anything in writing until he had an attorney, his oral statements to police were admissible).

(3) <u>Unconditional waivers permit renewed, contemporaneous interrogation on any case, by any officer, without new warnings or waivers.</u>

"A Miranda warning is not required before each custodial interrogation; one warning, if adequately and reasonably contemporaneously given, is sufficient." People v. Braeseke (1979) 25 Cal.3d 691, 701-02. Gratuitous repetition of warnings could prompt an invocation.

- A warning and waiver within at least the past **24 hours** before renewed interrogation is "contemporaneous." See *People v. Williams* (2010) 49 Cal.4th 405, 434-35 (40-hours OK); *People v. Mickle* (1991) 54 Cal.3d 140, 171 (36 hours OK); and cases cited in 1MB 2005-03. **But if a waiver were conditioned on talking** "now," new warnings would be required before any later resumption of questioning.
- Contemporaneous interrogation about a **different crime** does not require a new warning or waiver. *Colorado v. Spring* (1987) 479 US 564, 576-77. **But if a waiver were conditioned on talking** "about <u>this</u>" or "about <u>the charges</u> against you" or "about <u>the robbery</u>," etc., new warnings would be required before questioning about <u>other</u> crimes.
- A change in interrogating officers does not necessitate a new warning or waiver. *People v. Lewis* (2001) 26 Cal.4th 334, 386-87. Also, changes in location or jurisdiction do not require a new warning or waiver. *US v. Baron* (9th Cir. 1996) 94 F.3d 1312, 1320 (OK for DEA to question under contemporaneous waiver taken by state police). **But if a waiver were conditioned on talking** "to me" or "to us," a different officer would have to re-warn.
- These principles show the advantages of seeking *implied* waivers, which do not risk the inadvertent creation of a limiting condition. (*Exception*: if the suspect **invokes** and later re-initiates discussions, officers should take an *express* waiver of the right previously asserted, before resuming interrogation. *Oregon v. Bradshaw* (1983) 462 US 1039, 1045-46.)
- If an *express* waiver *is* sought following an admonition and acknowledgment of understanding, these principles support the advisability of simply asking: *"Do you want to talk about what happened?"* (Not *"now."* Not *"about these charges."* Not *"to me"* or *"to us."*)

<u>BOTTOM LINE</u>: The prospect of obtaining maximum admissible statements from a custodial suspect is not generally enhanced by seeking an *express* waiver, nor by inserting qualifiers that may result only in a *conditional* waiver.

Section 3.3.1.1 of the LDF plan document is amended to read: Representation in proceedings at the trial court level involving a domestic relation restraining order, including opposing its issuance and including seeking a firearm exemption under Family Law Code section 6389(h), but only to the extent that the proceedings impact the Participant's ability to perform the essential functions of the job.
- 2. Section 3.3.2 of the LDF plan document is amended by deleting "the following" from the first sentence.
- 3. The following is added as section 3.3.2.3 of the LDF plan document: "Upon a showing of good cause and subject to limitations imposed by the Administrator, representation in a civil or criminal matter in which the Participant is involuntarily called as a witness for trial or deposition, including representation to quash a subpoena or to negotiate with opposing counsel".
- 4. Current section 3.3.2.3 of the LDF plan document is renumbered as section 3.3.2.4.
- 5. The following is added as section 3.3.2.5 of the LDF plan document: "Upon a showing of good cause and subject to limitations imposed by the Administrator, representation in matters in which a Participant is objecting to placement by the Los Angeles District Attorney's Office in a disclosure system such as the Officer and Recurrent Witness Information Tracking System".
- 6. Section 4.6.2 of the LDF plan document is amended by deleting "Trustees" and inserting "Administrator".
- 7. The effective date of this amendment is May 24, 2019.

This amendment was adopted at a regular meeting of the Board of Trustees on May 24, 2019.

ALADS LEGAL DEFENS FUND AMENDMENT NUMBER THREE TO THE PLAN DOCUMENT (effective December 8, 2019)

Pursuant to article IX, section 1(B) of the LDF trust agreement and to section 7.1 of the LDF plan document, the Board of Trustees hereby amends the LDF plan document as follows:

- 1. Section 3.3.1.1 of the LDF plan document is amended to read as follows:
 - Representation in proceedings in which a restraining order, an emergency protection order, a protection order, or similar order based on allegations of domestic violence (collectively the "Orders") is sought against a Participant, including opposing its issuance and including seeking a firearm exemption under Family Law Code section 6389(h), but only to the extent that the proceedings potentially impact the Participant's ability to perform the essential functions of the job.
- 2. This plan amendment is effective thirty days after written notice has been given to the Board of Directors.

This amendment was adopted at a regular meeting of the Board of Trustees on September 20, 2019.
